**NOTICE OF PUBLIC HEARING  
ON PROPOSED ISSUANCE OF BONDS AND/OR NOTES  
BY THE MASSACHUSETTS HOUSING FINANCE AGENCY**

Public notice is hereby given that on the 2nd day of July, 2024, at 9:30 a.m., the MASSACHUSETTS HOUSING FINANCE AGENCY (“MassHousing”) will conduct a public hearing, by telephone as described below, for the purpose of giving all interested persons an opportunity to be heard on the proposed issuance by MassHousing of one or more issues of tax-exempt bonds or notes for proposed projects described herein. Such bonds or notes will be issued pursuant to a plan of finance and in accordance with Section 142 of the Internal Revenue Code, as amended, for the purpose of financing and refinancing the costs of acquisition, construction, of the multi-family residential rental project described below, including capitalized interest, and a portion of the costs of issuance.
